## Panama Canal Cruise - Norwegian Star - Ports of Call

### Cabo San Lucas, Mexico

This southernmost enclave on the tip of the Baja Peninsula features unearthly rock formations, cantinas owned by rock stars and hundreds of ways to enjoy yourself on, in, under and close to the water. Cabo is also blessed with a coastline that's ideal for kayak exploration, snorkeling, whale-watching and fishing.

### Acapulco, Mexico

As one of Mexico's oldest coastal tourist destinations, Acapulco has much to offer both tourist and traveler. Shop, swim or simply take a siesta on the beach. But be sure not to miss the legendary La Quebrada cliff divers.

### Puerto Quetzal, Guatemala

This port city was constructed in 1984 to help connect nearby cities. Travelers often venture out to Antigua, a 90-minute trek to where 17th century colonial facades beckons and Guatemalan history comes alive.

### San Juan del Sur, Nicaragua

Whether gliding across emerald waters on a catamaran or watching a world-class surfing spot, everyone can find a piece of paradise in San Juan del Sur.

### Puntarenas, Costa Rica

Located along the Pacific Coast of Costa Rica, Puntarenas is a great place to see native wildlife ranging from scarlet macaws to the alpha predator of Central America: the jaguar. Surfers from around the world regard this region of Costa Rica as prime surfing waters. As one of the country's leading fishing ports, Puntarenas is the perfect place
