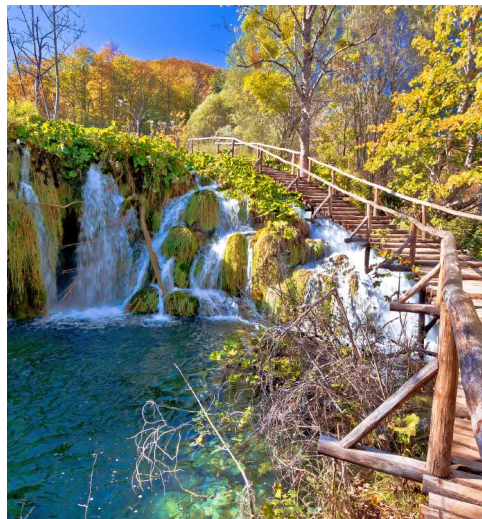

Day 1: Overnight Flight

Board your overnight flight to Europe.

Day 2: Arrive Zagreb, Croatia

Enjoy a panoramic **Zadar City Tour** to see the **Roman Forum** archeological site and the unique **Sea Organ**, which plays music by way of sea waves and tubes located underneath a set of large marble steps. Enjoy time for lunch before travelling along the spectacular coast arriving in **Split**. Located in the center of the Dalmatian Coast and nestled between the mountains and sea, Split is a picturesque ancient town built by the Roman Emperor Diocletian. Enjoy dinner with your fellow travelers this evening.

Day 4: Split Sightseeing

After breakfast, enjoy a **Split City Tour** highlighted by a visit to the impressive **Diocletian's Palace**, a UNESCO World Heritage Site built in the 3rd century. Highlights of the Palace include the Peristyle, the palace's main open space, Jupiter's Temple & the Cathedral which was once the Emperor's Mausoleum. The remainder of the day is at leisure to explore Split.

Day 5: Split - Dubrovnik

This morning, delight in a breathtaking drive along the spectacular **Dalmatian Coast**, dotted with palm trees, olive groves and idyllic fishing villages enroute to **Dubrovnik**. Enjoy a **Dubrovnik City Tour** featuring the harbor area, the **Franciscan Monastery** and the stately **Baroque Cathedral**. Later visit **Old Dubrovnik** which has been designated as a UNESCO World Heritage Site. Later check into your hotel for a two night stay and enjoy dinner with your fellow travelers.

Stop in the historic town of **Trogir** to see some of the medieval buildings, churches and towers of this enchanting city. Then have some time to shop and grab a bite to eat before continuing north. This afternoon features a scenic drive through Croatia's most beautiful countryside. Later arrive in Plitvice for an overnight stay. Enjoy dinner with your fellow travelers.
