## California Coast Itinerary

### Day 1: Arrive San Diego

### Day 5: Pismo Beach - Monterey

Then journey north along the spectacular **Big Sur Coast**, a route is nestled between the rocky coast and the Santa Lucia Mountains. Later this afternoon arrive in Monterey for a 2-night stay.

### Day 6: Monterey - Carmel
